SWT Council priorities

Somerset West and Taunton Council's updated priorities during the coronavirus outbreak are as follows:

- Preserve critical services;
- Safeguard the public;
- Ensure our most vulnerable residents are supported; and
- Planning economic resilience and recovery

The situation is being reviewed on a daily basis to ensure that the Council follows the [latest advice from Public Health England](#).

Key Messages this week

1. Somerset Unitary Bid

You may have all heard by now that the Secretary of State has given permission for Somerset County Council's Unitary bid to proceed. Under the plan branded 'One Somerset', Somerset County Council, SWT, Sedgemoor, Mendip and South Somerset District Councils would be replaced by one single unitary authority.

The Secretary of State has also invited District Councils to come up with an alternative proposal by mid-September and then allow an 8 week consultation period. The Government will make a decision later this year with an announcement early 2021.

A press release was issued by in conjunction with Mendip, Sedgemoor and South Somerset District Councils as follows:

“The district councils have been consistent in their view that real change is needed in local government in Somerset to deliver better outcomes for our communities. We are also agreed that a single unitary is the wrong solution for Somerset.

“Our joint work has always been about reform, not simple reorganisation, that will enable a stronger economy, stronger communities, stronger care and stronger, sustainable services. This will include a two unitary council solution.

“We have never been opposed to the creation of unitary authorities and the districts’ case will be a stronger and more ambitious alternative to the One Somerset proposal.

“As such, we are disappointed that Somerset County Council decided to issue a press statement about our proposals which contains confusing information and describes an announcement which has not yet happened.

“It is our full intention for the districts’ proposal to be democratically debated and shaped by our residents in the coming weeks, recognising that it needs to meet the different needs of our diverse communities while also delivering reform.”

2. Marking VJ Day Together

Taunton’s 40 Commando Royal Marines and the Mayor of Taunton are hosting a COVID-secure service to commemorate the 75th anniversary of VJ Day. The event, to recognise Victory over Japan, marking the end of the Second World War, will take place on **Saturday 15 August**, at the 40 Commando base in Norton Manor Camp.

Attendees will include The High Sheriff of Somerset, the Deputy Lord Lieutenant of Somerset, and Civic leaders from SWT and Somerset County Council alongside serving Armed Forces personnel and veterans. Whilst VE Day (Victory in Europe) marked the end of the war in Europe in May 1945, many thousands of Armed Forces personnel were still engaged in bitter fighting in the Far East.

Traditionally VJ commemorations are held in Vivary Park but COVID-19 restrictions have meant changes to the format of many Civic events this year. Although the service will be private this year there are many ways that

3. Electoral Registration Annual Canvass

Following the press release (included as an attachment to the newsletter) on 30 July 2020, a number of queries have been received from Councillors.

The annual canvass this year is different to the ones that have taken place in the past. All of our data was matched through the Cabinet Office against the data held at the Department of Work and Pensions, and 73% of households matched and were sent a letter (route 1) advising of the details we currently hold and no response was required unless there was a change.

The remaining 27% of households received a letter (route 2) advising of the details we currently hold and requesting they respond to confirm the details are correct or amend the details.

For the route 2 letters, there was an option to change details via the internet or by writing amendments on the form and sending back using the pre-paid envelope enclosed with the letter. If there were no changes, confirmation could be done via the internet, by Freephone, by SMS text or by post.

For the route 1 letters, there was an option to amend details using the internet or in writing, but no option for Freephone or SMS as we only required a response if there were changes.

At the top of all of our forms we include our team email address and telephone number and we make reference in the letter about our contact information should they need or want to contact us.

Forms began going out at the middle of last week and, to date, we have received 891 forms in the post, 493 automated telephone responses and 3619 automated internet responses.

The Elections team have been available on the phones answering queries and amending details from 8.30am until 5pm every working day and have not encountered any hostile interactions, in fact everyone has seemed happy.

Unfortunately, the forms this year are different to the forms used in previous years (the format and wording of the forms are set and we are not permitted to change them) so I understand that some residents will find them a little confusing.

5. Parking

Parking can be difficult, especially at the moment with more people working from home, but SWT would like to remind you to park considerately on the roads. Cars are often legally parked, but in a way that makes it difficult for recycling and rubbish collections trucks to negotiate narrower streets.

Somerset Waste Partnership (SWP) has recently had difficulties in making collections in a timely manner and have highlighted to people that if their truck can't get down a road, the same will probably apply for a fire appliance or ambulance. Consequently, staff working for SWP have been putting polite notices from the fire service on the windscreens of any problem parkers.

In addition to this, SWT asks its tenants to avoid parking on the grass verges on SWT housing estates. We've recently enjoyed some lovely dry weather but the grass verges around the estates can get churned up and become very muddy due to cars parking on them. Furthermore, it prevents SWT Parks & Open Spaces team from being able to undertake the necessary grounds maintenance works.

SWT knows it's difficult, but more than ever we'd ask people to park considerately for everyone's benefit.

6. Free Parking in SWT Car Parks set to end shortly

This is a polite reminder that free parking in SWT owned car parks is set to finish at the end of August. SWT hopes shoppers have taken advantage of the free parking and returned to our local High Streets, to shop safely and to support the local economy.

7. A Reminder to Councillors- Additional Support Available

SWT will be bringing in some temporary additional support for the Councillor case management and corporate feedback function.

Officers will predominantly be handling Councillor Cases and helping with complaint resolutions.

Partner Engagement - Key messages from other Public Service Areas

Somerset County Council (SCC)

Highway Maintenance Update

SCC Highways is currently focusing on the routine tasks of gully emptying, safety defect repairs and patching. You may well also see the carriageway surface dressing team out and about, carrying out aftercare tasks on the dressings that were laid in June.

SCC Highways has just experienced a very warm week in Somerset. Wednesday 12 August was the hottest day of the summer so far, with a temperature of 34 degrees Celsius (93 degF) in the shade recorded in Taunton. Readers may not be aware that SCC Highways has a network of roadside weather stations across the county, feeding back information about the Road Surface Temperature (RST) at each location. They are primarily installed to assist with winter service, such as when roads are expected to freeze. However, they send back information all year round and the highest RST recorded was at 3pm on the 12 August with 52.1 degrees Celsius (126 degF) at Pen Hill station on the A39 climbing the Mendips above Wells.

In Somerset West and Taunton, RSTs were almost as high with 51.0 degrees Celsius at A358 Obridge Viaduct, Taunton, and 50.7 degrees Celsius at Combeshead Cross, Brompton Regis. Surprisingly, only a few miles away at Copleham Cross, Bridgetown, the maximum RST was only 42.0 degrees Celsius, perhaps due to the more sheltered conditions on the valley floor of the River Exe.

The road resurfacing team is not working in Somerset West and Taunton at the moment, but rather further across the county at Glastonbury and Frome. Laying a hot material in such hot conditions can be quite a challenge!

M5 Junction 25 Improvement Scheme

Toneway

The current traffic management layout, which resembles the pre-construction layout, will be in place until early September. Works have continued with construction of the additional lane on the M5 gyratory along with the new pedestrian cycle route within the inner gyratory. Final surfacing works on the Toneway will be undertaken during overnight road closures early September this year to coincide with the final surfacing of the gyratory.

J25 Gyratory

Works have continued within all areas, including excavations, subbase, kerbing works along with installation of the new traffic signal ducting and streetlighting/signage. Near the new Blackbrook Bridge the cycle/pedestrian walkway has been re-routed which will allow the contractor to progress with the construction of the new lanes. Final surfacing to $\frac{3}{4}$ of the gyratory will be carried out during night-time closures in September.

Ruishton Junction

Works are ongoing at the junction/park and ride entrance with the attenuation pond completed this month. The new drainage and utility installations are progressing well. The contractor's site team is also focusing on the construction of the new roadways with a significant amount of surfacing work already completed.

Ruishton Lane will be temporarily closed in August for 5 weeks to allow works to underground services to be carried out.

Somerset's Local Outbreak Management Plan

Somerset's Local Outbreak Management Plan, setting out how the County Council and partners, will prevent and react to local coronavirus outbreaks, has been formally endorsed.

The COVID-19 Engagement Board held its first virtual meeting on Friday 31 July and was attended by members including Somerset's NHS Clinical Commissioning Group, district councils and the Avon and Somerset Police and Crime Commissioner. Members considered and backed the plan and its approach. The Board heard that Somerset cases continue to remain low compared to other parts of the country, but coronavirus is proving to be a disease around clusters and outbreaks, demonstrating the importance of local leadership in preventing and managing the spread.

Health and Welfare

Help Control the Virus

To protect yourself and others, when you leave home you must:

- wash hands - carry hand sanitiser and keep washing your hands regularly
- cover face - wear a face covering over your nose and mouth in enclosed spaces
- make space - stay at least a metre away from people not in your household and observe social distancing advice.

If you are feeling unwell, get a test and do not leave home for at least 10 days.

What is a Face Covering?

Face coverings are now compulsory in many indoor spaces like shops and supermarkets and on public transport. A face covering is a scarf, bandana, religious garment or hand-made cloth covering and they should:

- cover your nose & mouth at all times
- fit securely

Unless you have a legitimate reason not to, you must wear a face covering to protect others from the spread of infection.

Avon & Somerset Police (A&SP)

A Summary of PCSO Supervisor Sam Bushen's Latest Update

Over the last few months, Avon & Somerset Police have been really busy as lockdown restrictions have eased. Officers have worked hard to support local businesses re-opening, including the re-opening of the licensed premises across Taunton. In addition, they provided resources from Taunton to the many major events that have taken place across the constabulary. This included sending staff to Bristol to assist with protests, illegal raves taking place in different locations across the force and also with policing the many car enthusiast meets that have taken place either in Taunton or at Cheddar Gorge.

On top of those major events, Officers have been dealing with a rise in Anti-Social Behaviour (ASB) reports in parks and beauty spots. If ASB is taking place, please report it to the Police by calling 101 and not via a Facebook page. Furthermore, Police have been made aware of vehicles driving anti-socially.
