### Committee Meetings

Items on the agenda include Emergency Town Centre Recovery and back-fill of Economic Growth and Prosperity Fund and the creation of a Community Chest Fund. There are also confidential, commercially sensitive reports on Delivering Regeneration: Setting up a Special Purpose Vehicle and Tangier.
- Thursday 3 September - **Planning Committee**, 1pm (deadline for public questions or statements is 4pm on Friday 28 August). There is one planning application on the agenda relating to Wiveliscombe.
- Monday 7 September - **Audit, Governance and Standards Committee**, 6.15pm (deadline for public questions or statements is 4pm on Wednesday 2 September).
- Wednesday 9 September - **Special Meeting of the Scrutiny Committee**, 6.15pm (deadline for public questions or statements is 4pm on Friday 4 September)
- Thursday 10 September - **Special Meeting of Full Council**, 6.15pm (deadline for public questions or statements is 4pm on Monday 7 September)
- Monday 14 September - **Licensing Committee** - CANCELLED

### 3. Reminder parking charges set to resume

Charging will be reintroduced in SWT owned car parks from **Monday 31 August**. The Council introduced free parking at the start of the coronavirus lockdown and extended the offer as part of its wider plan to support the re-opening of High Streets and help rejuvenate the local economy.

SWT has taken the decision to start charging again in line with other district councils in Somerset, although key health workers, on duty who display permits provided by their NHS Trust can continue to park for free. Signage will be placed in the car parks reminding people that charges now apply. All SWT car parks are now fully open except Paul Street Car Park where the top three levels remain closed until they can be opened safely under COVID-19 guidance.

### 5. SWP Sites and Services

**No collections on the Summer Bank Holiday Monday 31 August**, means recycling and rubbish services are one day later all week, including Friday pick-ups on **Saturday 5 September**.

The changes affect collections of recycling, refuse and garden waste, as well as assisted collections. Residents should sort and segregate materials, ensure no recycling - especially food - is in the rubbish bin, and put all waste containers out by 7am.

Recycling sites remain on their usual timetables, with all 16 sites open 9am-4pm on the Bank Holiday Saturday and Sunday weekend. 12 sites will be open 9am-6pm on Bank Holiday Monday: **Bridgwater, Minehead, Taunton, and Williton.**

All kerbside collections return to their usual schedules from **Monday 7 September.**

## **Partner Engagement - Key messages from other Public Service Areas Somerset County Council (SCC)**

### **Highway Maintenance Update**

SCC Highways are currently focusing on the routine tasks of gully emptying, safety defect repairs and patching. You may well also see the carriageway surface dressing team out and about, carrying out aftercare tasks on the dressings that were laid in June.

Another unseasonal week for weather. After “Storm Ellen” the previous week, this time it was “Storm Francis”. Probably not as wet or long lived as “Ellen” but a more intense event with stronger winds for a shorter period of time. The afternoon of Tuesday 25 August was probably the worst and a number of trees and branches fell onto the highway in quick succession.

Although there were problems right across the county, with the winds on this occasion being predominantly westerlies, Somerset West and Taunton was worst hit. The A38 Wellington Relief road was closed overnight and the B3227 Milverton Bypass was closed into the evening as difficult tree extractions were carried out in very adverse conditions.

The week finished off with more rain as another unseasonal low blew in off the Atlantic. Let’s hope that the Bank Holiday and the last week of the school holidays have much better weather for us all.

Rural verge cutting on the “A” and “B” road networks has now been completed.

### **Concessionary fares: change from 1 September**

In March SCC decided to relax the Concessionary Fare Scheme times, for concessionary bus pass holders to make essential journeys before 9.30am during the Covid-19 pandemic.

From 1 September SCC is re-introducing the 9.30am scheme start time, so that there is sufficient capacity on the network for the return of school and college students. Bus operators have been notified of this change, and bus passes will not be accepted on ticket machines before 9.30am unless travelling on an exempted route.

### **Student Bus Tickets**

Due to the on-going Covid-19 pandemic, Somerset County Council will not be offering the County Ticket scheme for the 2020/21 academic year.

Due to potential social distancing measures and possible changes to the level of College attendance required from September 2020, an annual pre-paid ticket is not the most viable option.

Due to the potential reduction in the number of days students may need to attend College, the County Ticket option would not be the most cost-effective solution for students at this stage. For those students needing to travel via public transport, then purchasing one of the ticket options offered by the public transport operators would be more cost-effective.

### **M5 Junction 25 Improvement Scheme Toneway - Creech Castle Works Update**

Works undertaken by contractor, Alun Griffiths at Junction 25 are progressing well, and in conjunction with Somerset County Council they will shortly be starting some advanced works along the **A38 Bridgwater Road** ahead of the main Creech Castle project which has been postponed until next year.

### **HMRC Self-Employment Income Support Scheme Webinar**

Self-employed people whose business earnings have been hit by coronavirus can now apply for a second support grant from the government until 19 October. HM Revenue and Customs have added new dates for their webinar about the Self-Employment Income Support Scheme (SEISS), Universal Credit and Child Benefit. ### **Kick Start Grant- Tourism and Business Recovery**

The Government confirmed [£10 million of funding to boost tourism](#) and a further [£20 million to boost business recovery](#) in England. The Kickstart Grant

**The grant scheme is not yet live. It is hoped the grant will be launched by the end of the month.**

This year's festival will be going ahead with a fantastic range of events for families and adults. Great care has been taken by event organisers to ensure that all events will be COVID-safe and most are therefore exclusively for small groups/bubbles or less than 30 people. As such, you stand to get an even more personal experience. Some events are run by the Exmoor National Park Authority, and others are organised by local groups and businesses.

The webpage is being updated daily with more event details and booking links as they are confirmed. As events are generally for smaller numbers, early booking for all is highly advisable. Booking in advance will always be required - there will be no events where you can just turn up on the day.

## **Coronavirus: Changes to MOTs**

There are some changes to MOT tests because of coronavirus. How this affects you depends on when your MOT was due to expire.

If your MOT was due between 30 March and 31 July 2020 your MOT will be automatically extended for 6 months because of coronavirus.

Example: Your vehicle's MOT was due to expire on 3 April 2020 this will automatically be extended to 3 October 2020. You will need to get your MOT by this date.

If your MOT was due before 30 March or after 31 July 2020 you must [book an MOT as usual](#).

You must not take your vehicle for its MOT if either:

- [you or someone you live with has coronavirus \(COVID-19\) symptoms](#)
- you've been told by the NHS Test and Trace service that you've been in contact with someone who has coronavirus.

You must stay at home (self-isolate) if either of these situations apply.

### **Action on Addiction**

#### **A Change in Drinking Patterns during Coronavirus**

Action on Addiction is seeing and hearing evidence that people in the UK are drinking differently as a result of coronavirus. In post COVID recovery we are attending our zoom meetings, building virtual communities, and, together over video chats, we address our fears, anxiety, share moments of celebration or sadness and support each other. But for others, this experience has meant persistent fear, anxiety and an unfathomed dimension of loneliness and isolation - the bedfellows that feed addiction.

So, when does an extra glass or two of wine to numb the effects of watching the news turn into problem drinking? How can you tell? How far into the afternoon does the 6pm beer, or prosecco need to move for it to be a sign that something's not quite right? And even if it's out of boredom rather than desire for anaesthesia, when does the tolerance developed by drinking become more like dependence? Where is the line?

## **FAQS**

**Q. What else will change in the next few months?**

**A.** From 1 September, schools, nurseries and colleges will open for all children and young people on a full-time basis. Universities are working to reopen as fully as possible. The Government is committed to doing everything possible to allow all children to go back to school safely, to support their wellbeing and education and help working parents. The Government's plan is for all students in England to return to education settings in September. You can find out more about [the government's approach to education](#) and how schools are preparing.

From 1 October, if prevalence remains around or below current levels, the Government hopes to bring back audiences in stadiums, and allow conferences and other business events to recommence in a COVID-19 Secure way. From November, the ambition is to scale back remaining social distancing measures, but this is contingent on a number of factors, including consideration of the specific challenges as we move into winter.



**Q. Can I book a driving test for my son / daughter now?**

**A.** Yes, you can book a driving test, however, the Driver and Vehicle Standards Agency (DVSA) has confirmed there has been an unprecedented demand for driving tests since it reopened to the general public on 21 August. The service will only be taking bookings for the next 6 weeks. DVSA has introduced a queuing system for people using the service. You'll get a number and see where you are in the queue.
