5 HERITAGE UPDATE

8. GREEN CORRIDOR ADVISORY BOARD

9. CLIMATE CHANGE STRATEGY

To consider proposed actions for the delivery of the Climate Change Strategy. A paper is attached for consideration which if approved will be developed in to a detailed action plan.

10. LOCAL CYCLING AND WALKING INFRASTRUCTURE PLAN (LCWIP) UPDATE

To consider recommending to the Full Council that a draft submission, prepared by Wellington Wheelers at the request of the Town Clerk in relation to providing protected space for cycling through the town, be included in the LCWIP.

11. BASINS ALLOTMENTS ADVISORY BOARD

- (i) It was proposed by the Policy and Resources Committee and subsequently agreed by Full Council that an Advisory Board should replace the current Allotments Committee arrangements. The Board will report to this Committee. Proposed Draft Terms of Reference are attached for consideration.

12. TREE STRATEGY

- (i) Fruit Tree Project. To consider recommending to Full Council that it commits £5,400 from the Environmental Improvement Budget for the purchase of 300 dwarf apple trees to be given free of charge to residents and schools. A paper is attached for consideration.

13. REQUEST FOR LITTER BIN

A request has been received from a resident for a new bin on Popes Lane adjacent to the entrance to Andrew Allen Road. Somerset Council will no longer install any additional bins given the recent replacement scheme for larger units. They also expect the unit to be similar to those which have been recently installed. Council Officers are waiting for Somerset Council to provide the cost to purchase and install which will be circulated prior to the meeting or provided at the meeting.

If the Committee approve the request, It is asked that the Officers be given delegated authority to purchase an appropriate unit and approve the cost for installation if permission is granted for siting by Highways. Emptying will be carried out by Somerset Council at a cost of \pounds 7.33 per time (2x per week, x52 weeks = \pounds 1,524.64 per year).

14. SIGN FOR ROLY POLY GREEN

Councillor Booth has requested signage to be put up at Roly Polly Green. He has suggested that a competition for the design be run for primary school children. Permission will be required from Somerset Council, but the committee is asked to consider this in principle and recommend to Ful Council that delegated authority is given to Officers and Councillor Booth to set up the competition and approve costs in line with the Committee's Terms of Reference.

To consider a list of potential actions for the Committee from a list of suggestions provided to the Town Centre Committee. Paper attached to the agenda.
