### 8 ALLOTMENTS

- (i) Basins Allotments The Committee had previously agreed expenditure of £500 for the hire of skips to clear some allotments. The Committee is asked to approve further expenditure of £460 as a result of needing to clear more allotments than originally thought.
- (ii) Longforth Farm Allotment Site to receive an update on progress and to recommend to the Town Council that the £50,000 cost of developing the allotments should be met from the Community Infrastructure Levy funding received from the Lidl Development.

# 13 RED PHONE BOX - TONEDALE

#### 14 TOWN CENTRE RAILING PLANTERS

The railing planters have now been in place for approximately six months. Maintenance work is required to ensure the planters and plants are in their best condition for the Spring/summer plants. Work required as follows:

- 1) Replace any dead plants.
- 2) To refill planters with compost.
- 3) Watering and feeding of plants during the spring and summer months.
- 4) Putting in new perennial flowering plants.
- 5) To make any necessary repairs to the framework and planters

**RECOMMENDATION:** The Committee to give the Town Clerk delegated spending power up to £1,000 to cover the cost of maintenance work required. To be funded from the 2023/24 Town Centre Projects budget line.
