523 TO CONSIDER WHAT COMMENTS TO MAKE ON THE FOLLOWING APPLICATIONS THAT WILL BE DETERMINED BY SOMERSET COUNCIL

(a) Case Refs: 43/23/0113 & 43/23/0114/LB

Proposal: Replacement of skylight with 2 No. conservation style roof lights at 37A Fore Street, Wellington (retention of part works already undertaken)

RESOLVED to recommend approval of this application.

(b) Case Refs: 43/24/0003 & 43/24/0004/LB

Proposal: Installation of staircase with creation of separate access to the rear to improve retail accommodation and reinstate the upper floors to 1 No. self contained flat at 14 Fore Street, Wellington

RESOLVED to recommend approval of this application.

(c) Case Ref: 43/24/0006/T

Proposal: Notification to re-pollard one Plane tree to previous pollard points within South Road Conservation Area at Wellington School, South Street, Wellington

RESOLVED to note the application, Councillors were happy to defer to the expertise of the Tree Officer.

(d) Case Ref: 43/24/0007/T

Proposal: Application to fell ('monolith') one cypress tree and to carry out management works (crown-reduction) to one ash and one hornbeam included in Taunton Deane Borough (Wellington No.1) Tree Preservation

RESOLVED to note the application, Councillors were happy to defer to the expertise of the Tree Officer.

(e) Case Ref: 43/24/0008/CLA

Proposal: Notification for prior approval for the removal of mast and antenna and installation of 1 No. 22.5 metre high street pole and associated ancillary development thereto on land at Scott's Lane, Wellington

RESOLVED to recommend that this application be refused on the same basis as when it was considered previously, and before it was withdrawn, namely:

'The proposal, being double the height of the existing as well as the associated apparatus being large and prominent, is not appropriate for the location of the current mast. It will be overbearing on nearby residential, commercial, and school properties. It will be visible from the Town Centre and will have a detrimental impact on the visual outlook of the Conservation Area.'

In addition, the Council considered that the application should not be considered as a Permitted Development given that its height exceeds 15m which is the limit as set out in The Town and Country Planning (General Permitted Development) (England) Order 2015 Part 16 Item A.1(b).

(f) Case Ref: 43/24/0011

Proposal: Erection of 7 No. commercial buildings with change of use and conversion of 2 No. agricultural buildings to commercial use with alterations to access and associated works at Chelston House Farm, Taunton Road, Wellington

RESOLVED to recommend that this application be approved in principle. However, it noted that advice from Highways was not available and traffic access and egress was a potentially significant issue. It also asked that advice and guidance from other agencies e.g. Fire was noted and acted on.

(g) Case Ref: 43/24/0012/CMA

Proposal: Application to determine if Prior Approval is required for a change of use and conversion from commercial, business and service use (Class E) into 1 No. dwelling (Class C3) at 7a North Street, Wellington

RESOLVED to recommend that this application be approved.

Proposal: Display of 1 No. internally illuminated 7m EV Totem Pole sign at Wellington Service Station, Westpark, Chelston

RESOLVED to recommend that this application be refused. The Council considered that there were already sufficient, if not too many, illuminated sigs on the site with more to come and that one identifying the site as having EV charging was not necessary especially given that EVs have an app that locates charging points.
