1. Event overview

The plan is for the Street Fair to consist of a mix of approximately 90 traders and community group stalls. It provides local traders the opportunity to sell their products directly to customers and gives people in the community the knowledge of how their food was grown and produced, It also enables local crafters and businesses, community groups and schools to sell their goods and raise money. The criteria for traders can be found on our website www.wellingtontowncouncil.co.uk. Music Entertainment will take place on stage. There will also be street entertainers.

2. How this event will impact the road network

There will be two road closures – High Street and South Street. A Traffic Management Plan detailing road closures and diversions has been produced by Bridgwater Guy Fawkes Carnival Ltd and submitted to Somerset County Council

3. Is there impact on public transport

Buses do use the High Street. All bus companies have been contacted to advise of the road closure and sent a copy of the map detailing the closure and diversion routes. The High Street is usually closed to traffic for events two or three times a year, so bus companies will be aware of the impact on their routes and be able to plan accordingly.

4. How post office vehicle movements will be managed

There will be two road marshalls at the top of White Hart Lane and at the road closure at the end of High Street junction with North Street, South Street and Fore Street. All marshalls will have radio communication to ensure the post office can carry out normal service - see attached Road and Stall Layout Plan for the High Street – Yellow Arrows indicating Royal Mail Lane. The Postmaster has been notified in writing of the event and road closures. To date no concerns have been raised.

5. Car Parking arrangements

Public parking in North Street Car Park, South Street Car Park and Longforth Road Car park

6. Are buses and taxis affected and if so, what communication has taken place with them and what arrangements have been put in place?

See answer to question 3 above. Local Bus and Taxi Companies have been notified of road closure and Traffic Diversion Plan provided

7. Blue Badge Parking - These bays in High Street will not be in use - where will blue badge holders park instead?

There will be Blue Badge Parking available in North Street Car Park, South Street Car park and Longforth Road Car Park as well as along Fore Street.

8. Carer access arrangements for properties in High Street

Event Posters are displayed on the town centre notice board and on social media platforms e.g. facebook. These have been shared with local community groups, schools etc.,

Road Closure signage will be put up by Bridgwater Guy Fawkes Carnival Ltd prior to the event. Car Parks are located around the town centre so carers will be able to park in them at no cost and can easily walk to High Street and South Street.

9. Site Description and Access Points

High Street and South Street, Wellington will be closed. Barriers will be positioned at both ends of the streets with two marshalls at each point. Marshalls will have radio communication with Day Managers/Event Co-ordinator.
